Most interesting to me in the years of talking to people about their experiences in health care?

In every conversation, there's no sense of a shared experience with health care. Everyone feels like they're going at this alone, which is often reflected as a personal failure to manage this complex system rather than a systemic issue.

When people feel alone, they can't imagine change — let alone dream of a system reformed to meet their needs.

USofCare knows the key to longstanding reform is **changing the conversation** of what a health care system would look like based **on shared values across people, and using every tool we have to drive change in the near and long-term**. Through listening to people across demographics — USofCare has adopted these four goals as our North Star for change. These drive the work we do.

- ★ People have the security and freedom that dependable health care coverage provides as life changes.
- ★ People can get the personalized care they need, when and how they need it.
- ★ People experience a health care system that's understandable and easy to navigate.

The cracks in the health care system and its longstanding disparities became wider and wider.


The nation started a long-overdue — and continuing — reckoning with racial injustice after the murder of George Floyd.

Impact for People

Using Research to Shape Our COVID-19 Response Priorities

USofCare's listening work in 2020 related to the pandemic, which has long-term implications, demonstrating people's shared desire for:

Accurate health information and clear recommendations



Ability to provide care to ourselves and for our loved ones



COVID-19 Rapid Response

We are ensuring a strong response to the pandemic to build a better health care system.

Our Efforts:

- ★ Responded to more than 150 requests from more than 30 states for COVID-related technical assistance and support through our Rapid Response effort.
- ★ Sent over 35 e-updates to 700 state executive and legislative leaders with COVID-19 response resources and highlights of innovative state actions.

Successes in States

Change requires targeted progress and our team of experts knows how to navigate the political system to achieve tangible wins.

We work at the state and federal levels to secure legislative and executive solutions that most effectively eliminate the barriers people face to accessing affordable health care.

We know how the political system works and which levers to pull in order to reach desired results. Our team takes a multi-faceted approach to provide resources, strategic advice, and technical assistance while sharing best practices with partners on the ground across the country.

We released policy recommendations for <u>state executive and legislative action</u>, a <u>preparedness handbook</u> to help state leaders prepare for future spikes of COVID-19, and a <u>guide for states</u> on how to prepare for COVID and the flu converging.

Successes in States

We cultivated relationships with **21 additional legislators** in **11 states** with diverse political leadership. Topics covered include:

- **†** Public option
- \star Medicaid expansion
- \star Improved access to behavioral health care



<u>We released a brief</u> on state-based solutions to improve mental health care (in partnership with Well Being Trust).



Post-election, USofCare shared materials with incoming state senators and representatives on how to meet their constituents' needs. Examples include: a <u>memo on state funding options,</u> **policy recommendations** and corresponding **blog for states** to address post-pandemic, <u>recommendations</u> for the upcoming flu season, and **efforts to standardize consumer affordability**.

In 2021, USofCare converted these contacts into our State Leader distribution list, where we will continue to share resources, recommendations, and highlight progress across states.

Driving Federal Action



USofCare released four sets of **federal recommendations** for Congressional response legislation informed by our Founder's Council and reflecting everyday people's needs. Many of these priorities have been included in the **COVID response legislation**, including significant investments in detecting, diagnosing, tracing, and monitoring COVID-19 infections and a new Health Care Ready Reserve. **Sent the incoming Biden-Harris Administration** a <u>federal transition memo</u> with robust recommendations in four key areas to improve our health care system and respond to the pandemic and resulting economic downturn.

USofCare brought together more than 20 Board, Founders and Entrepreneurs Council members to think through immediate steps that should be taken to address the pain points we know exist for people.



Educating Voters & Candidates

Health care remained one of the most important challenges facing America during the COVID pandemic. USofCare was doing our part to inform and engage policy makers and voters during the 2020 Election.



USofCare encouraged Americans to participate in our democracy and exercise their right to vote on November 3, 2020. While COVID-19 meant fewer state fairs, parades, and forums, there were still opportunities to become an informed voter and engage with candidates.

- Released a <u>2020 Voter Action Guide</u> to empower and educate voters.
- Hosted a live virtual event featuring Andy Slavitt and comedian Mike Birbiglia with more than 300 participants, providing voters with key tools, questions, and messages to communicate with candidates.

7 states + 2,600 candidates

USofCare completed state legislative <u>candidate</u> <u>education materials</u> for seven states (CO, GA, MI, MN, NV, PA, TX), shared with more than 2,600 candidates in August, and provided a webinar for the Georgia Democratic caucus to inform their members and candidates. These materials were featured in the <u>Washington Post Health 202</u>. ★ Initiated a relationship with the Latino Caucus for Public Health (a section of the American Public Health Association), and co-presented a webinar on the USofCare Voter Action Guide and discussion on civic engagement for their young professionals virtual forum.
